In January 2018, the total Global ETP Assets under Management (AuM) grew to US\$ 5,052bn from US\$ 4,758bn in December 2017 (+6.2% month-on-month, source: BlackRock ETP Landscape January 2018). That translates into a total Global ETP AuM in euro terms of € 4,055bn in January 2018 versus € 3,962bn in December 2017, with an EUR/USD FX rate of 1.24575 (rate end January 2018).

The average VIX for the month of January reached 10.99 (versus 10.17 in December), with an intraday low of 8.92 (versus 8.90 as a low in December) and an intraday high of 15.42 (versus 14.58 in December) (Source: Bloomberg).
